## **ELIGIBILITY CRITERIA**

- New equipment must be installed on cooperative's lines. Resale equipment, new parts installed in existing equipment or equipment that is rebuilt, rented, received from insurance claims, received from a warranty or won as a prize does not qualify.
- Incentive not to exceed the equipment cost.
- Incentives are in place through December 31, 2024. Funds are limited so submit required documentation as soon as possible.
- \* Required documentation must be submitted within 3 months of install date. If submitted after December 31, 2024, equipment will be considered for the 2025 incentive if offered.
- Additional eligibility criteria may apply. Program is subject to change or cancellation without notice. Contact cooperative for details.
- System-Specific Solar Electric (PV) System Requirements:
  - ✓ System must be installed within 90 degrees of due south
  - ✓ System must be installed with a panel tilt between 10 50 degrees
  - ✓ System must be installed with 10% or less obstacle shading, per an industry accepted tool
  - ✓ System must have a minimum of a five-year warranty
  - ✓ Both modules (panels) and inverter must be installed to receive an incentive
  - System must be installed by a qualified contractor.
- Required documentation listed below must be submitted no later than 3 months after install date.
  - ✓ This incentive form
  - √ A copy of your receipt or invoice for each item with purchase price(s) circled
  - ✓ Documentation showing the array has been installed
